With all the challenges we faced in 2023 wherein we experienced a price increase of many daily necessities, we all remain faithful in giving our tithes & offering to our Lord Jesus Christ. Overall, our church, International Worship Centre still managed to increase its revenue by \$280,376 compared to our revenue from 2022, that is because of you, all faithful givers. As the leadership of the church carefully planned all our events and activities, we only incurred a minimal increase in expenses, thus generating a higher net revenue of \$223,229.
